1. Call to Order and Approval of Agenda:

3. Business Arising from Past Minutes:

(A) UPDATE ON EQUIPMENT FOR REMOTE ACCESS TO VHF RADIO BROADCASTS:

- JPS quote: \$1,000 for ROIP box + free software for PC + \$200.00 for cable + replacement VHF radio (total, one-time of cost: ~ \$2,000.00)
- cell-phone access would require monthly fee (likely minimal)
- system lacks ability to change channels for privacy, but otherwise has basic features that we require using the current radio
- will also need a fixed IP address for TLA building
- Rob will investigate additional options.

(B) TLA SUPPORT FOR TAFIP:

• The TAFIP is developing an online system for donations. The TLA will share information with its members when everything is finalized.

(c) Update on 2020 Summer-Staff Recruiting Prospects:

- An advertisement will appear in the Winter 2020 edition of the *Temagami Times*.
- The ad has also been placed on the website, and sent to the Municipality, TFN, the Chamber of Commerce, and Temiskaming District Secondary School for distribution.
- Sam Mitchell may be available for a couple of weeks in the summer of 2020. There may
 also be a student who is available to assist at the HQ building through completion of her 40
 hours of community service.
- Other strategies re: HQ building services (e.g., mail delivery) are also being considered.

(D) UPDATE ON OFFICIAL PLAN AMENDMENT FOR SECONDARY DWELLING UNITS AND THE PROPOSED ENCROACHMENT BY-LAW:

- A meeting will take place on March 20, 2020 (with comments due by March 12, 2020) re: allowing secondary dwelling units to be built, and home businesses to be established, on properties throughout the Municipality.
- Board members will send a series of questions/concerns to Paul, who will then create and submit a response letter to the Municipality on behalf of the TLA.
- The Municipal Council vote on the encroachment by-law has been deferred until the Spring due to issues highlighted by the TFN.

(E) ALOEROOT WEBSITE PROPOSAL - PENDING:

- Brit and Linda spoke with Steph at AloeRoot Web Services re: online membership payment and updating options. People could also make contributions to the Tenets, TERAS, and radio-service funds, pay for their property patrols, and purchase merchandise through a "shopping cart" system.
- Linda created a "confidentiality agreement" form, which was subsequently approved by Margaret. It was signed by both Steph and Linda.
- Steph developed a proposal for review and forwarded it on February 28, 2020.
- More information is required before a firm decision is made.

(F) Proposed Acknowledgement of TAA Ancestral Lands:

- Peter, Terry, and Linda developed a draft version for review.
- Peter, Brit, and Margaret will discuss this further, and report back at the next Board meeting.
