# (A) COMMITTEE UPDATES:

 The hydro disconnect in 2025 should be coordinated with the MNR – in part, to determine how much of the underground connection should remain in place.

## (B) OP UPDATE:

- The MHBC planners will provide a brief update to the Temagami Council at the November 14, 2024 regular Council meeting.
- They indicated that the Final Draft of Temagami's "Official Plan" will not be ready to present to Council at this meeting. They have received many constructive comments for consideration in developing this final draft, but may also have to include updates related to the new "Provincial Policy Statement" (which became affective in October). Therefore, they require additional time to review all comments and to provide a thorough and updated final version of the OP.
- As MHBC is not available for the December 2024 Council meeting, they are suggesting that adoption of the Final Draft of the OP could be completed at the January 2025 meeting (when their planners can attend).
- Once adopted by Council, the Final Draft of the OP will be sent to the Ministry of Municipal Affairs and Housing (MMAH) for final approval. The timeline for this is unknown.

### (C) MUNICIPAL UPDATES:

 The Timiskaming Health Unit may amalgamate with the Porcupine Health Unit on January 1, 2025 – but, this is not certain at this time.
